**STATEMENT OF ISSUE**

The issue is whether Respondent proved by a preponderance of the evidence that Respondent's decision to terminate prescribed pediatric extended care ("PPEC") services was correct.

**PRELIMINARY STATEMENT**

All parties appeared telephonically. Petitioner's Authorized Representative, [REDACTED]

[REDACTED] appeared on behalf of the Petitioner. [REDACTED]

[REDACTED] appeared as a witness for Petitioner. [REDACTED] was present for the hearing but did not participate.

Chrissie Simmons (“Ms. Simmons”), Medical/Health Care Program Analyst and Fair Hearing liaison for the Agency for Health Care Administration (“Agency” or “AHCA”), appeared on behalf of Respondent. Dr. Chris Kunis (“Dr. Kunis”), Medical Director for eQHealth Solutions, Inc., appeared as a witness for Respondent.

Rodrick, interpreter number 68007277 with Global Interpreting Network, appeared to offer translation services for Petitioner. Kimberly Roche, Hearing Officer with the Office of Fair Hearings, appeared as an observer.

Prior to the hearing, Petitioner sent to the Office of Fair Hearings and Respondent a twenty-one (21)-page evidence packet. The twenty-one (21)-page evidence packet appears in the Office of Fair Hearings’ document management system as file title “22-FH2219 Faxed Evidence.pdf”. Absent an objection from Respondent, the undersigned admitted the twenty-one (21)-page evidence packet into evidence as Petitioner’s Composite Exhibit 1 (“PCE 1”).

Prior to the hearing, Respondent sent to the Office of Fair Hearings and Petitioner a one-hundred and twenty-four (124)-page evidence packet and a forty-six (46)-page evidence packet. The one-hundred and twenty-four (124)-page evidence packet appears in the Office of Fair Hearings’ document management system as file title “[REDACTED] FH 02.24.2023.pdf”. The forty-six (46)-page evidence packet appears in the Office of Fair Hearings’ document management system as file title “[REDACTED] Evidence.pdf”. Absent an objection from the Petitioner, the undersigned admitted the one-hundred and twenty-four (124)-page evidence

packet into evidence as Respondent’s Composite Exhibit 1 (“RCE 1”) and the 46-page evidence packet into evidence as Respondent’s Composite Exhibit 2 (“RCE 2”).

**FINDINGS OF FACT**

1. Petitioner receives Medicaid services on a fee-for-service basis from the Agency. eQHealth is a Quality Improvement Organization (“QIO”) contracted by the agency to review prior authorization requests for services. See page 2 of RCE 2.

2. At the date of the hearing, Petitioner was [REDACTED]. See page 16 of RCE 1.

Petitioner is diagnosed with: [REDACTED]  
[REDACTED]. *Id.* at

16-18. Petitioner has an age-appropriate diet and is dependent of all activities of daily living (“ADLs”). *Id.* at 18. Petitioner had not had an [REDACTED]

3. Petitioner requested continuation of PPEC services, specifically 728 units of code T1026 (Partial day services) and 182 units of code T1025 (Full day services). In a Notice of Outcome (“NOO”), dated October 26, 2022, Respondent terminated Petitioner’s PPEC services. *Id.* at 23-

24. The NOO explained the basis of the termination as follows:

[T]he requested services are not medically necessary under the following standard(s):

Individualized, specific, and consistent with symptoms or confirmed diagnosis of the illness under treatment, and not in excess of the patient’s needs.

Reflective of the level of service that can be safely furnished, and for which no equally effective and more conservative or less costly treatment is available statewide.

...

The NOO further stated:

Submitted information does not support the medical necessity for requested services.

Clinical Rationale for Decision: [REDACTED]  
[REDACTED]

The patient is on a regular diet, has been cleared by cardiology for pulmonary hypertension, only current medications are [REDACTED] [REDACTED] [REDACTED] [REDACTED] in the past [REDACTED]. Nursing needs consist of PRN [REDACTED].

Deny all PPEC units. The patient lacks sufficient skilled nursing needs to warrant PPEC care.

...

Pages 23-24 of RCE 1.

4. Petitioner requested reconsideration of the Respondent's decision. In a Notice of Reconsideration Determination ("NRD") dated November 10, 2022, Respondent upheld its decision. *Id.* at 38 – 39. The NRD explained the basis of the decision as follows:

PR Recon Determination: The patient is a [REDACTED] and a history of [REDACTED] who is progressing nicely. [REDACTED] is on an age appropriate diet and [REDACTED] only medications are [REDACTED] [REDACTED] which has not been administered at PPEC. There have [REDACTED] [REDACTED] [REDACTED]. [REDACTED]  
[REDACTED]

There is no longer a need for skilled nursing services; therefore, PPEC has to be denied.

...

Pages 38-39 of RCE 1.

5. On November 28, 2022, Petitioner requested a Fair Hearing to challenge the termination of PPEC services. *Id.* at 8. On February 1, 2023, the undersigned issued an Order Scheduling Fair Hearing by Telephone and Prehearing Instructions, setting the hearing for February 24, 2023, at 1:00 p.m. EST.

6. Dr. Kunis is a Medical Director for eQHealth Solutions, Inc. Dr. Kunis testified to the following at the Fair Hearing:

- a. Petitioner is medically stable, progressing well, and would benefit from an educational setting. Petitioner does not meet medical necessity for skilled nursing services.
- b. Petitioner's conditions are stable. PPEC services were indicated in the past, but the termination of Petitioner's PPEC services is now appropriate.
- c. Petitioner's [redacted] is administered as needed.

7. [redacted] testified to the following at the Fair Hearing:

- a. Petitioner's health conditions have improved. Petitioner requires the continuation of PPEC services and intensive therapy to treat [redacted] diagnoses.

**CONCLUSIONS OF LAW**

9. The Agency's Office of Fair Hearings has jurisdiction over the subject matter of this proceeding and the parties pursuant to section 409.285(2) of the Florida Statutes (2019). This order is the final administrative decision of AHCA under Fla. Stat. § 409.285(2)(a).

10. This hearing was held as a *de novo* proceeding pursuant to Fla. Admin. Code R. 59G-1.100(17)(b).

11. Because Respondent terminated an existing service, Fla. Admin Code R. 59G-1.100(17)(g) assigns the burden of proof to Respondent. The standard of proof in an administrative hearing is a preponderance of the evidence. The preponderance of the evidence standard requires proof by “the greater weight of the evidence” (Black’s Law Dictionary at 1201, 7th Ed.)

12. The PPEC Policy establishes the provision and coverage of PPEC services under Florida Medicaid. The PPEC Policy states as follows:

**1.1 Description**

Florida Medicaid prescribed pediatric extended care (PPEC) services provide skilled nursing supervision and therapeutic interventions in a non-residential setting to medically dependent or technologically dependent recipients.

...

**2.2 Who Can Receive**

Florida Medicaid recipients under the age of 21 years requiring medically necessary PPEC services and who:

- Require continuous therapeutic interventions or skilled nursing supervision, as described in section 400.902, F.S., and in Rule 59A-13.007, F.A.C.
- Are determined stable by a physician and who are not a threat to self or others

...

**1.3 Definitions**

The following definitions are applicable to this policy. For additional definitions that are applicable to all sections of Rule Division 59G, F.A.C., please refer to the Florida Medicaid definitions policy.

...

**1.3.7 Medically Necessary/Medical Necessity**

As defined in Rule 59G-1.010, F.A.C.

...

**4.0 Coverage Information**

**4.1 General Criteria**

Florida Medicaid covers services that meet all of the following:

- Are determined medically necessary
- Do not duplicate another service
- Meet the criteria as specified in this policy

...

## **5.0 Exclusion**

### **5.1 General Non-Covered Criteria**

Services related to this policy are not covered when any of the following apply:

- The service does not meet the medical necessity criteria listed in section 1.0
- The recipient does not meet the eligibility requirements listed in section 2.0
- The service unnecessarily duplicates another provider's service

13. Rule 59A-13.007(4)(a), F.A.C. states the following:

(4) Each child admitted for service to a PPEC center must meet at least the following criteria:

(a) Infants and children considered for admission to the PPEC center will be those who are medically or technologically dependent. . . .

...

Further, section 400.902, F.S described "medically dependent or technologically dependent child" as follows:

[A] child who because of a medical condition requires continuous therapeutic interventions or skilled nursing supervision which must be prescribed by a licensed physician and administered by, or under the direct supervision of, a licensed registered nurse.

14. Rule 59G-4.290 defines skilled nursing as follows:

(3) Skilled Services Criteria.

- a) To be classified as requiring skilled nursing or skilled rehabilitative services in the community or in a nursing facility, the recipient must require the type of medical, nursing or rehabilitative services specified in this subsection.
- b) Skilled Nursing. To be classified as skilled nursing service, the service must meet all of the following conditions:
  1. Ordered by and remain under the supervision of a physician;
  2. Sufficiently medically complex to require supervision, assessment, planning, or intervention by a registered nurse.
  3. Required to be performed by, or under the direct supervision of, a registered nurse or other health care professionals for safe and effect performance;
  4. Required on a daily basis;

5. Reasonable and necessary to the treatment of a specified documented illness or injury; and,
  6. Consistent with the nature and severity of the individual's condition or the disease state or stage.
- c) Examples of services that qualify as skilled nursing services:
1. Intravenous medication or fluids.
  2. Intramuscular or subcutaneous injection and hypodermoclysis when:
    - a. Administered by licensed nursing personnel at least 5 times weekly, excluding daily insulin administration; and,
    - b. Observation is necessary to assess the recipient's response to treatment or to identify adverse reactions.
  3. Management and monitoring medication regime on a daily basis:
    - a. For drugs whose dosage requirements may rapidly change;
    - b. For drugs prone to cause adverse reactions, severe side effects or unfavorable reactions; and,
    - c. For residents with unstable reactions.
  4. Levin tube and gastrostomy feedings; excluding feedings performed by residents, family members, or friends.
  5. Administration of medical gases, aerosolized medication or oxygen which is started, monitored and regulated by professional staff.
  6. Naso-pharyngeal and tracheotomy aspiration, excluding tracheotomy care in self-care residents.
  7. Insertion, replacement, and sterile irrigation of catheters when:
    - a. Medically necessary or required for reasons other than to maintain satisfactory catheter functioning and dryness;
    - b. The medical need is documented by the physician;
    - c. Continuous irrigation, frequent insertion, special care or observation is required because of bleeding, infection, obstruction, or heavy sediment formations; and,
    - d. Care of a recently inserted supra-pubic catheter, inserted within 2-4 weeks, is required.
  8. Colostomy and ileostomy care:
    - a. When medically necessary and required during early postoperative period;
    - b. During the period of initial self-care training, or
    - c. when complications are present and documented in the medical record.
  9. Treatment of decubitus ulcers when:
    - a. Deep or wide without necrotic center;
    - b. Deep or wide with layers of necrotic tissue, or

c. Infected and draining.

10. Treatment of widespread infected or draining skin disorders.
11. Application of dressings involving prescription medication and aseptic techniques when documented as required on a daily basis. Excludes simple dressings involving non-infected cases, simple skin breaks, and healed postoperative incisions.
12. Heat treatments prescribed by a physician as daily treatment for a specific condition.
13. Rehabilitation nursing procedures required on a daily basis as necessary to restore functioning, including teaching and adaptive aspects of nursing.

15. States must provide Early and Periodic Screening, Diagnostic, and Treatment (“EPSDT”) services to Medicaid-eligible children under age 21 when requested under the Medicaid state plan. See 42 U.S.C. § 1396a(a)(43); 42 U.S.C. § 1396d(a)(4). According to 42 U.S.C. § 1396d(r)(5), EPSDT services mean, in relevant part, the following items and services:

Such other necessary health care, diagnostic services, treatment, and other measures described in subsection (a) of this section to correct or ameliorate defects and physical and mental illness and conditions discovered by the screen services, whether or not such services are covered under the state plan.

16. Petitioner is under age 21, and therefore eligible for EPSDT services. However, a state may place medical necessity limitations on EPSDT services. See 42 C.F.R. §§ 440.230(a), (b), (d).

17. Fla. Stat. § 409.905(2) limits EPSDT services with a medical necessity standard:

The [Agency] shall pay for early and periodic screening and diagnosis of a recipient under age 21 to ascertain physical and mental problems and conditions and all services determined by the agency to be medically necessary for the treatment, correction, or amelioration of these problems and conditions, including personal care, private duty nursing, durable medical equipment, physical therapy, occupational therapy, speech therapy, respiratory therapy, and immunizations.

18. The Florida Medicaid Definitions Policy, incorporated by reference in Fla. Admin. Code R. 59G-1.010, defines “Medically Necessary” or “Medical Necessity” as follows:

The medical or allied care, goods, or services furnished or ordered must meet the following conditions:

- Be necessary to protect life, to prevent significant illness or significant disability, or to alleviate pain
- Be individualized, specific, and consistent with symptoms or confirmed diagnosis of the illness or injury under treatment, and not in excess of the patient's needs
- Be consistent with generally accepted professional medical standards as determined by the Medicaid program, and not experimental or investigational
- Be reflective of the level of service that can be safely furnished, and for which no equally effective and more conservative or less costly treatment is available statewide
- Be furnished in a manner not primarily intended for the convenience of the recipient, the recipient's caretaker, or the provider

The fact that a provider has prescribed, recommended, or approved medical or allied care, goods, or services does not, in itself, make such care, goods or services medically necessary or a medical necessity or a covered service.

19. In the NOO, dated October 26, 2022, Respondent terminated Petitioner's PPEC services.

See ¶ 3. The NOO explained that the basis for the termination was that PPEC services were not "individualized, specific, and consistent with symptoms or confirmed diagnosis of the illness under treatment", and were "in excess of the patient's needs". *Id.* Further, PPEC services were determined not to be "reflective of the level of service that can be safely furnished, and for which no equally effective and more conservative or less costly treatment is available statewide". *Id.*

20. PPEC services are intended for patients who "require continuous therapeutic interventions or skilled nursing supervision". See ¶ 12. As provided by the EPSDT requirements, the recipient must meet the medical necessity criteria as outlined in Fla. Admin. Code R. 59G-1.010. As provided in the Definitions Policy, a component of medical necessity is that such services must be "[i]ndividualized, specific, and consistent with symptoms or confirmed diagnosis

of the illness under treatment, and not in excess of the patient’s needs”. See ¶ 19. Further, as provided in the Definitions Policy, another component of medical necessity is that such services must be “reflective of the level of service that can be safely furnished, and for which no equally effective and more conservative or less costly treatment is available statewide”. See ¶ 19. As shown by the record, Petitioner has [REDACTED]


See ¶ 2. However, Dr. Kunis testified that Petitioner’s conditions are also stable. See ¶ 6. Moreover, Dr. Kunis provided credible testimony that Petitioner does not require skilled nursing services as Petitioner uses [REDACTED]. *Id.* Dr. Febo testified that [REDACTED] opinion was that Petitioner’s delays warrant daily therapy and that it may difficult for Petitioner to find a daycare. However, it was not shown that Petitioner needed skilled nursing services.

21. Upon consideration of the testimony provided, evidence submitted, and applicable polices, the undersigned concludes that Respondent proved by a preponderance of the evidence that continuing PPEC services was not medically necessary for Petitioner. Looking at all the evidence relevant to the particular needs of Petitioner, Respondent has demonstrated that PPEC services are not necessary to correct or ameliorate a defect or a physical and mental illness or condition. Accordingly, Respondent proved by a preponderance of the evidence that Respondent’s termination of PPEC services was correct.

**IT IS HEREBY ORDERED AND ADJUDGED THAT:**

Respondent’s denial is **AFFIRMED**. Petitioner’s appeal based on Respondent’s denial is **DENIED**.


