FINAL ORDER

At all times relevant to this proceeding, Petitioner received Medicaid benefits on a fee-for-service basis. On March 6, 2023, [REDACTED] (“Petitioner’s Authorized Representative”) requested a Fair Hearing based on Respondent’s partial denial of Behavior Analysis services.

A Hearing Officer may deny or dismiss a Fair Hearing request if the Recipient files a written withdrawal of the request. A Hearing Officer may also deny or dismiss a Fair Hearing request if the Recipient testifies on the record that he or she wishes to withdraw the request. See Rule 59G-1.100(9)(b)(5)(a), Florida Administrative Code.


On April 20, 2023, the hearing was held before the undersigned Hearing Officer, with the Petitioner’s Authorized Representative, and the Respondent in attendance. Under oath, the Respondent issued a statement explaining that the services requested have been approved. At that time and on the record, Petitioner’s Authorized Representative withdrew the request for Fair Hearing.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA APPELLATE RULES. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF THE RENDITION OF THE ORDER TO BE REVIEWED.
