FINAL ORDER

At all times relevant to this proceeding, Petitioner received Medicaid benefits on a fee-for-service basis. On August 23, 2023, [REDACTED] (“Complainant”) requested a Fair Hearing based on Respondent’s denial of applied behavior analysis services. On September 15, 2023, the Office of Fair Hearings received a signed Designation of Authorized Representative naming [REDACTED] [REDACTED] as Petitioner’s Authorized Representative.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA APPELLATE RULES. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF THE RENDITION OF THE ORDER TO BE REVIEWED.
