**FINAL ORDER**

At all times relevant to this proceeding, Petitioner received Medicaid benefits on a fee-for-service basis. On February 5, 2024, [REDACTED] (“Complainant”) requested a Fair Hearing based on Respondent’s termination of behavior analysis services.

A Hearing Officer may deny or dismiss a Fair Hearing request if the Recipient files a written withdrawal of the request. A Hearing Officer may also deny or dismiss a Fair Hearing request if the Recipient testifies on the record that he or she wishes to withdraw the request. See Rule 59G-1.100(9)(b)(5)(a), Florida Administrative Code.

On April 4, 2024, the hearing was held before the undersigned Hearing Officer, with the Fair Hearing Complainant and the Respondent in attendance. At that time and on the record, Respondent reversed its decision in this case and authorized the behavior analysis services at issue, as follows: 2,080 units of code 97153, 208 units of code 97155, and 104 units of code 97156. Whereupon Complainant withdrew the request for Fair Hearing.

Based on the foregoing,

**IT IS THEREFORE ORDERED AND ADJUDGED THAT:**

Petitioner's Fair Hearing request is hereby deemed withdrawn, and this matter is now closed.
