**FINAL ORDER**

At all times relevant to this proceeding, Petitioner received Medicaid benefits on a fee-for-service basis. On March 7, 2024, [REDACTED] ("Complainant") requested a Fair Hearing based on Respondent's denial of Behavior Analysis services.
