**FINAL ORDER**

At all times relevant to this proceeding, Petitioner received Medicaid benefits through Simply Healthcare Plans, Inc. On July 18, 2024, [REDACTED] (“Complainant”) requested a Fair Hearing based on Respondent’s denial of prescription drug [REDACTED].

A Hearing Officer may deny or dismiss a Fair Hearing request if the Recipient files a written withdrawal of the request. A Hearing Officer may also deny or dismiss a Fair Hearing request if the Recipient testifies on the record that he or she wishes to withdraw the request. *See* Rule 59G-1.100(9)(b)(5)(a), Florida Administrative Code.

On September 10, 2024, the hearing was held before the undersigned Hearing Officer, with the Fair Hearing Complainant and the Respondent in attendance. At that time and on the record, Sharon Nealy, Grievance and Appeals Fair Hearing Coordinator for Respondent, testified that Respondent reversed its decision and authorized the prescription drug at issue on September 6, 2024. Whereupon, Complainant withdrew the request for Fair Hearing.

**IT IS THEREFORE ORDERED AND ADJUDGED THAT:**

Petitioner's Fair Hearing request is hereby deemed withdrawn, and this matter is now closed.

REVIEW PROCEEDINGS SHALL BE CONDUCTED IN ACCORDANCE WITH THE FLORIDA APPELLATE RULES. THE NOTICE OF APPEAL MUST BE FILED WITHIN 30 DAYS OF THE RENDITION OF THE ORDER TO BE REVIEWED.
